Supplementary Distribution GOP / GOP VR: YouTube, Facebook, Instagram collections 2021

Dear member,

Your pay-outs dated 01/01/2023 may contain in your document "Gutschrift zu Kontoauszug" the following supplement items:

- GOP 2021 K Zuschlag YouTube
- GOP 2021 T Zuschlag Facebook Instagram
- GOP VR 2021 V Zuschlag YouTube

These are compensations in the categories GOP and GOP VR (Streaming Mixed Online-Platforms) made for collections from YouTube, Facebook and Instagram lacking (usable) usage-reports. These collections can be allocated to paneuropean areas of use in 2021. The Facebook, Instagram distribution contains TikTok royalties of previous years, that had not been paid by TikTok in time for the last distribution.

Pursuant to Art. 182e distribution plan, the distribution shall be carried out to rights holders as a supplement to the respective annual income for financial year 2021 in separated category-groups:

- „Live performances & Music playbacks“ (BM, DK, DK VR, E, ED, EM, KI, U, UD)
- „Radio“ (R, R VR)
- „Television & Filmscreening“ (FS, FS VR zu 1/10, T, TD, TD VR, T FS, T FS VR, VOD, VOD VR)
- „Reproduction & Distribution“ (BT VR, PHONO VR)
- „Online“ (KMOD, KMOD VR, MOD, MOD VR, WEB, WEB VR)
- „International“ (A, A VR)



The rounded average percentual supplement amounts to:

The commission in the categories GOP and GOP VR amounts to 10%. In addition, there is a deduction of 10% in the category GOP for social and cultural purposes (pursuant to Art. 30 [1] of the distribution plan).
